Horse riding, as a sport in the open air with a living animal whose reactions can be unpredictable, is a risky sport, therefore: **the federal licence** allowing you to benefit from insurance and the wearing of a riding helmet, or a bomb approved (CE 1384) by the FFE is compulsory, as well as boots with mini chaps, the wearing of a CE EN 13158 approved protective waistcoat is strongly recommended and compulsory for outdoor sessions and jumping sessions. Children must wear suitable clothing (trousers and jacket suitable for the sport), with their hair tied back, otherwise they will not be allowed to attend the lessons. It is essential to personally equip yourself with your own halter, gaiters, rug, back pad, and grooming equipment (regularly washed and disinfected) identified with your name. Lockers are available for hire, payable at the beginning of the term, to store your belongings.

Returns that are not cancelled 24 hours in advance on the Cavasoft online management platform are considered to have been made.

When the rider registers for a session, a training course, a competition or any other service, a time slot is reserved for him/her, thus allowing the management of the riding facilities, the sports installations, and the staff of the establishment. Any service paid in advance allows the client to benefit from a preferential rate for a fixed period. It is not refundable, except for medical reasons.

COMPETITION LICENCE

The Club Competition licence is free, annual, and compulsory for those who want to compete, but requires a **PARENTAL AUTHORIZATION** and a **FAVOURABLE MEDICAL CERTIFICATE AUTHORIZING THE PRACTICE OF EQUITATION IN COMPETITION**, which can be downloaded from the FFE website with your licence number and your SIF code (to be requested at the reception desk if necessary). In addition, future competitors adhere to the attached sporting code of good conduct. Entries, coaching, and transport are payable in advance.

Parents and children accompanying the rider(s) must not look after the horses.

They must not ride cars, bicycles, rollerblades, skateboards, or other vehicles on the club premises, and must not approach the horses in the stables. Any accident involving a member of the riding school outside the hours of resumption or a non-member, will not engage the responsibility of the riding school.

Minors registered with the club are under the responsibility of the club for half an hour before the lesson, during the lesson and for half an hour after the lesson. Outside this period, they are no longer under the responsibility of the club, which cannot ensure their supervision.

Dogs of accompanying persons must be kept on a lead.

The teachers choose the most suitable equine for the rider for the course being taught (walking, lunging, dressage, jumping, cross country or outdoor). This is to avoid overworking certain horses or ponies, and the regular change of equine will help your child to progress quickly.

The club is a member of the FFE and as such can offer its riders a federal licence for practice or competition. The licence for riders allows them to take the federal exams (Galops, Degrees) and to benefit from reductions or preferential rates on equipment and leisure activities as part of the Licence Advantages. The competition licence allows you to participate in federal competitions.

Any member who has entered his or her email address can receive Le Mel Cavalier FFE containing practical information on partnerships - in particular on the biggest competitions - and have privileged access to www.ffe.com thanks to his or her FFE Rider Page.

Riding can expose a rider to the risk of accident and/or physical injury. It is therefore strongly recommended that riders take out civil liability insurance as well as a individual accident insurance. The FFE licence entitles the holder to free third-party liability insurance for damage caused to third parties by the rider, as well as individual accident insurance for damage suffered by the rider. The

amount of the guarantees can be consulted on the FFE Rider Page on the website www.ffe.com or on equi.generali.fr.

The rider undertakes to carefully consult the amount of cover offered and, if necessary, to request additional insurance to provide better cover.

Rules of Procedure

The rider and his/her companions declare that they have read and accepted the internal regulations applicable within the establishment and posted on the sign provided for this purpose. The rider and his/her companions undertake to respect these rules. Any breach of these rules is a breach of the present contract and may lead to exclusion from the establishment.

Protection of personal data

The rider accepts to be listed in the club's file and benefits directly from the club's right of access, portability, and rectification in accordance with the amended law of 6 January 1978. The equestrian establishment has a computer file containing data provided by clients who have expressly agreed to it. The purpose of this file is to manage the daily activities of the establishment and in particular the organization of riding lessons, the daily life of the equestrian establishment, the registration for training courses and sporting competitions, etc.

Only persons with secretarial and managerial functions within the institution have access to these data in the context of their duties.

The data is kept for 5 years after the end of the contractual relationship. He can exercise his rights by sending a simple e-mail to the establishment's e-mail address

Fitness and Medical Certificate

All riders declare that they have a medical certificate stating that they are not contra-indicated to practice horse riding, including in competition (governmental decree of 10 June 1971, article 6), or failing that, they release the club from any consequences of a possible contra-indication. It is recommended to be up to date with the tetanus vaccination.

In the event of an accident requiring an urgent intervention, he/she or his/her legal representative authorizes the Ecuries du Moulin Moreau to take any decision concerning the transport and hospitalization of his/her child.
